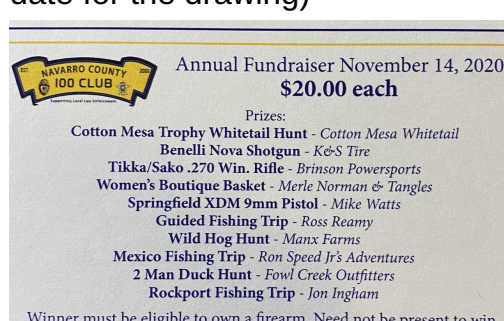
Other Texas 100 Clubs News
